A substitute ordinance relating to parking controls.

COMMON COUNCIL

This ordinance establishes the above-mentioned parking requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-23-2 of the Code relating to No Stopping is amended by striking the following:

"On the east side of North 35th Street from a point 95 feet south of the south curb line of West Vienna Avenue to a point 278 feet north thereof at any time"

Part 2. Section 101-23-3 of the Code relating to No Parking is amended by striking the following:

"On the east side of North 35th Street from a point 310 feet north of West Capitol Drive to a point 110 feet further north at any time"

"On the east side of North 35th Street from a point 200 feet north of the north curb line of West Capitol Drive to a point 130 feet further north at any time"

"On the east side of North 35th Street from the north curb line of West Townsend Street to a point 75 feet north thereof at any time"

"On the east side of North 35th Street from a point 110 feet north of the north curb line of West Vienna Avenue to a point 20 feet further north thereof at any time"

"On the east side of North 35th Street from the first curb line of West Capitol Drive to a point 126 feet south thereof"

"On the east side of North 35th Street from the south curb line of the south roadway of West Congress Street extended, to a point 229 feet south thereof at any time"

"On the east side of North 35th Street from a point 135 feet south of the south curb line of West Toronto Street to a point 70 feet south thereof, at any time"

"On the west side of North 35th Street from a point 200 feet north of the north curb line of West Capitol Drive to a point 40 feet north thereof at any time"

"On the west side of North 35th Street from a point 290 feet north of the north curb line of West Capitol Drive to a point 130 feet further north thereof at any time"

"On the west side of North 35th Street from the south curb line of West Nash Street to a point 67 feet south thereof, at any time"

Part 3. Section 101-23-3 of the Code relating to No Parking is amended by adding the following:

On the west side of South 9th Street from a point 556 feet north of West Grange Avenue to a point 14 feet north thereof from 7:00 AM to 5:00 PM Monday through Friday

Part 4. Section 101-23-4-c of the Code relating to One-Hour Parking is amended by striking the following:

"On East Kenilworth Place from North Prospect Avenue to North Summit Avenue"

Part 5. Section 101-23-4-c of the Code relating to One-Hour Parking is amended by adding the following:

On the north side of East Kenilworth Place from North Prospect Avenue to North Summit Avenue

On the south side of East Kenilworth Place from North Summit Avenue to a point 135 feet west

Part 6. Section 101-23-4-d of the Code relating to Two-Hour Parking is amended by striking the following:

"On the west side of North 35th Street between West Hope Avenue and West Marion Street, except Saturdays and Sundays"

Part 7. Section 101-32-3-b-6 of the Code relating to Three-Hour Meter Parking is amended by adding the following:

On the south side of East Kenilworth Place from a point 70 feet east of North Prospect Avenue to a point 100
