THE CHAIR

Substitute resolution determining it necessary to make various assessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$42,000 for a total estimated cost of these projects being \$425,000.

This resolution authorizes engineering studies and directs the Commissioner of Public Works to determine any benefits or damages which would result if the projects were to be constructed. After the Commissioner files his report, a Public Hearing will be held on those projects determined assessable. A resolution will be submitted after the Public Hearing authorizing construction. The City cost for engineering these projects is estimated to be \$42,000 with the total cost estimated to be \$425,000.

Resolved, By the Common Council of the City of Milwaukee that it is necessary and in the public interest to do the following described work according to City specifications, and that such public improvements and resulting special assessments be made pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances:

1st Aldermanic District

Alley betw. W. Florist Av., W. Kaul Av., N. 39th St., N. 40th St. (ST212220104) Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund - \$15,000) The total estimated cost for this project including the requested amount is \$100,000. This

project is anticipated to be completed during the 2023-2024 construction season.

7th Aldermanic District

Alley betw. W. Capitol Dr., W. Fiebrantz Av., N. 44th St., N. 45th St.(ST212220102) Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund - \$15,000) The total estimated cost for this project including the requested amount is \$125,000. This project is anticipated to be completed during the 2023-2024 construction season.

Alley betw. W. Glendale Av., W. Ruby Av., N. 41st St., N. 42nd St.(ST212220103) Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund - \$10,000) The total estimated cost for this project including the requested amount is \$95,000. This project is anticipated to be completed during the 2023-2024 construction season.

13th Aldermanic District

Alley betw. W. Eden Pl., W. Morgan Av., S. 9th Pl., S. 11th St. (ST212200101) File Number 200921: Paving the alley with concrete. Doing all the necessary grading pertaining to said work. (Nonassessable Alley Paving Fund - additional funds \$2,000) The total estimated cost for this project including the requested amount is \$105,000. This project is anticipated to be completed during the 2023 construction season.

Further Resolved, That the abutting and adjacent properties be assessed a portion of the cost, said assessment to be recommended by the Commissioner of Public Works in his report; and, be it

Further Resolved, That all assessments and payments be made in accordance with Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That all City departments are authorized to do engineering, surveying, preparing of plans, and estimates of cost thereof, to be utilized in the preparation of said report of the Commissioner of Public Works; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
