This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$5,982,415.00. The total estimated cost of these projects is \$7,248,280.20.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

6th Aldermanic District

PCB REMOVAL - 4132 N. Holton St. (SM495220014) File Number 211997: Sanitary sewer PCB removal. (Nonassessable Sewer Maintenance Relay Fund - \$395,000). The total estimated cost of this project including the requested amount is \$400,000. This project is anticipated to be completed during the 2022 construction season.

#### 7th and 10th Aldermanic Districts

Traffic Island Bioswales - Various Locations (SM499190015) File Number 191658: (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements - additional funding \$25,000). The total estimated cost of this project including the requested amount is \$305,000. This project is anticipated to be completed during the 2022 construction season.

#### 8th Aldermanic District

S. 35th St. - 15' North of W. Pierce St. to W. Pierce St. (WT410220644) File Number 201552: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. This project is anticipated to be completed during the 2022 construction season.

N. 17<sup>th</sup> St. - W. Galena St. to W. Walnut St. (WT410220688) File Number 201552: Relaying water main and Lead replacement of service. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$110,000). The total estimated cost of this project including the requested amount is \$125,000. This project is anticipated to be completed during the 2022 construction season.

N. 39th St. - W. Meinecke Ave. to W. Center St. (SM495210102) File Number 211199: Combined sewer relay. (Nonassessable Sewer Maintenance Relay Fund -- \$565,000). The total estimated cost

of this project including the requested amount is \$580,000. This project is anticipated to be completed during the 2022 construction season.

The total estimated cost of this project including the requested amount is \$292,000. This project is anticipated to be completed during the 2022 construction season.

The total estimated cost of this project including the requested amount is \$445,000. This project is anticipated to be completed during the 2022 construction season.

W. Wright St. -N. 35th St. to N. 46th St. (SM495210109) File Number 211343: Combined sewer relay. (Nonassessable Sewer Maintenance Relay Fund -- \$1,300,000). The total estimated cost of this project including the requested amount is \$1,325,000. This project is anticipated to be completed during the 2022 construction season.
