THE CHAIR

A substitute ordinance relating to a change in zoning from Two-Family Residential to Industrial-Office, for parking lot expansion, on land located South of West National Avenue and East of South 22nd Street, in the 8th Aldermanic District.

This zoning change was initiated by the owner, David Samuel, to allow for the expansion of the surface parking lot adjacent to the north. Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances a new section to read as follows:

Section 295-801.1.0003. The zoning map is amended to change the zoning for the South 30 feet of Lot 7, in Block 16, of Clark's Addition, in the Southwest 1/4 Section of Section 31, Township 7 North, Range 22 East, from Two-Family Residential (RT4) to Industrial-Office (IO2). DCD:AJF:ajf 02/01/10
