WHEREAS, Travaux Inc. solicited sealed bids by Official Notice Number 58093 during the period February 25, 2022 through March 11, 2022 for Flooring (TCP-13.1-RB) for Townhomes at Carver Park; and

WHEREAS, one sealed bid was received by the deadline of 2:00 PM (CST) on March 11, 2022; and

WHEREAS, the sealed bid was received and publicly opened on March 11, 2022, during which the bidding procedure was conducted in compliance with the requirements of local, state, and federal regulations; and

WHEREAS, BYCO Inc., a qualified and competent bidder, submitted the lowest responsive and responsible bid in the amount of \$1,076,740.00; therefore, be it,

RESOLVED, by the Board of Directors of Travaux Inc. that it hereby authorizes and approves accepting the bid of and entering into a contract with BYCO Inc. for Flooring (TCP-13.1-RB) for Townhomes at Carver Park; and, be it
