Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$1,069,375 for a total estimated cost of \$1,561,900.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$1,069,375. The total estimated cost of these projects is \$1,561,900.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

### 1st Aldermanic District

N. 53rd St. - W. Villard Ave. to W. Custer Ave. (ST211210281) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$4,995; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$16,400. This

project is anticipated to be completed during the 2022 construction season.

N. 54th St. - W. Fairmount Ave. to W. Villard Ave. (ST211210282) Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund - \$4,140; Nonassessable Reconstruction Paving Fund - \$500). The total estimated cost for this project including the requested amount is \$16,600. This project is anticipated to be completed during the 2022 construction season.

W. Kiley Ave. - N. 37th St. to N. 40th St. (ST211220122) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$3,350; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$13,300. This project is anticipated to be completed during the 2022 construction season.

Alley betw. W. Hope Ave., W. Marion St., N. 62nd St., N. 63rd St. (ST212210103) File Number 211085: Concrete alley pavement reconstruction including permeable pavers, and grading. (Assessable Alley Paving Fund - \$62,580; Nonassessable Alley Paving Fund -- \$80,000). The total estimated cost for this project including the requested amount is \$250,000. This project is anticipated to be completed during the 2022-23 construction season.

N. 72nd St. - W. Silver Spring Dr. to W. Thurston Ave. (ST211220133) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$1,845; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$7,900. This project is anticipated to be completed during the 2022 construction season.

W. Ruby Ave. - N. 73rd St. to N. 74th St. (ST211220132) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$420; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2022 construction season.

W. Scranton Pl. - W. Custer Ave. to W. Sheridan Ave. (ST211210236) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$3,780; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$11,900. This project is anticipated to be completed during the 2022 construction season.

W. Thurston Ave. - N. 73rd St. to N. 74th St. (ST211210235) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$655; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$7,200. This project is anticipated to be completed during the 2022 construction season.

#### 5th Aldermanic District

N. 87th St. - W. Lisbon Ave. to W. Melvina St. (Incl. W. Elmore Ave. - N. 87th St. to N. 88th St. (ST211200129) File Number 200358: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6.5' width of tree border area), and grading. (Assessable Reconstruction Paving Fund - \$75,035; Nonassessable Reconstruction Paving Fund -- \$525,000). The total estimated cost for this project including the requested amount is \$650,000. This project is anticipated to be completed during the 2022-23 construction season.

This project is anticipated to be completed during the 2022 construction season.

Alley betw. W. Becher St., W. Rogers St., S. 35th St., S. 36th St. (ST212140109) File Number 120251: Concrete alley pavement reconstruction including permeable pavers, and grading. (Assessable Alley Paving Fund - \$61,350; Nonassessable Alley Paving Fund -- \$90,000). The total estimated cost for this project including the requested amount is \$250,000. This project is anticipated to be completed during the 2022-23 construction season.

W. Brentwood Ave. - N. 85th St. to N. 89th St. (ST211190119) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$4,770; Nonassessable Reconstruction Paving Fund -- \$500). The total estimated cost for this project including the requested amount is \$23,000. This project is anticipated to be completed during the 2022 construction season.

N. 75th St. - W. Chambers St. to W. Burleigh St. (ST211220129) Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund - \$1,910; Nonassessable Reconstruction Paving Fund - \$500). The total estimated cost for this project including the requested amount is \$7,300. This project is anticipated to be completed during the 2022 construction season.

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved That a portion of the speed hump projects will be utilizing ARPA (American Rescue Plan Act) funds: The project/grant number is RG1515236102; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it
