Whereas, ESInet is the infrastructure that is able to deliver Next Generation 9-1-1 (NG9-1-1) voice and text 9-1-1 calls via an Internet Protocol (IP) network; and

Whereas, NG9-1-1 is capable of providing more accurate 9-1-1 caller location information and has the capacity to send other types of data such as pictures and video; and

Whereas, The Participation Agreement authorizes AT&T to survey both the City's and AT&T's infrastructure to identify any needed improvements necessary for both sides to facilitate connection to the State's ESInet system; and
