THE CHAIR

Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$62,465 for a total estimated cost of \$146,100.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$62,465. The total estimated cost of these projects is \$146,100.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

1st Aldermanic District

N. 33rd St. - W. Villard Ave. to W. Custer Ave. (ST211220141) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$2,575; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$12,500. This project is anticipated to be completed during the 2022 construction season.

N. 38th St. - W. Custer Ave. to W. Sheridan Ave. (ST211220145) Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund - \$2,390; Nonassessable Reconstruction Paving Fund - \$1,500). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2022 construction season.

N. 40th St. - N. Hopkins St. to W. Villard Ave. (ST211220140) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$1,505; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2022 construction season.

N. 48th St. - W. Luscher Ave. to W. Fairmount Ave. (ST211220163) Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund - \$3,710; Nonassessable Reconstruction Paving Fund - \$1,500). The total estimated cost for this project including the requested amount is \$11,700. This project is anticipated to be completed during the 2022 construction season.

N. 50th St. - W. Luscher Ave. to W. Fairmount Ave. (ST211220143) Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund - \$3,325; Nonassessable Reconstruction Paving Fund - \$1,500). The total estimated cost for this project including the requested amount is \$12,400. This project is anticipated to be completed during the 2022 construction season.

W. Carmen Ave. - N. 27th St. to N. 29th St. (ST211220162) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$2,320; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2022 construction season.

N. Darien St. - W. Cheyenne St. to W. Vera Ave. (ST211220142) Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund - \$1,430; Nonassessable Reconstruction Paving Fund - \$1,500). The total estimated cost for this project including the requested amount is \$7,500. This project is anticipated to be completed during the 2022 construction season.

W. Lancaster Ave. - N. 42nd St. to N. Sherman Blvd. (ST211220123) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$265; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2022 construction season.

N. 61st St. - W. Marion St. to W. Congress St. (ST211220167) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$2,245; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2022 construction season.

W. Stark St. - N. 60th St. to N. 61st St. (ST211220176) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$755; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2022 construction season.

W. Thurston Ave. - N. 97th St. to N. 98th St. (ST211220151) Install traffic calming speed hump(s).

(Assessable Reconstruction Paving Fund - \$170; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$7,500. This project is anticipated to be completed during the 2022 construction season.

7th Aldermanic District

N. 29th St. - W. Concordia Ave. to W. Townsend St. (ST211220154) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$2,745; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2022 construction season.

N. 49th St. - W. Hope Ave. to W. Marion St. (ST211220146) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$2,400; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2022 construction season.

N. 49th St. - W. Townsend St. to W. Keefe Ave. (ST211220153) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$1,490; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2022 construction season.

N. 56th St. - W. Parkway Dr. to W. Hampton Ave. (ST211220150) Install traffic calming speed hump (s). (Assessable Reconstruction Paving Fund - \$5,045; Nonassessable Reconstruction Paving Fund - \$1,500). The total estimated cost for this project including the requested amount is \$16,200. This project is anticipated to be completed during the 2022 construction season.

10th Aldermanic District

N. 53rd St. - W. Clarke St. to W. Center St. (ST211220195) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$2,165; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$7,300. This project is anticipated to be completed during the 2022 construction season.

N. 58th St. - W. Wright St. to W. Clarke St. (ST211220169) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund - \$2,430; Nonassessable Reconstruction Paving Fund -- \$1,500). The total estimated cost for this project including the requested amount is \$7,100. This project is anticipated to be completed during the 2022 construction season.

Resolved, By the Common Council of the City of Milwaukee, that the Commissioner of Public Works' Report, as amended at said Public Hearing, is approved and the properties therein identified are benefited; and, be it

Further Resolved, That said Commissioner of Public Works is authorized and directed to proceed with said work in accordance with said report pursuant to Section 66.0703 and any other pertinent sections of the Wisconsin Statutes and in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved That a portion of the speed hump projects will be utilizing ARPA (American Rescue Plan Act) funds: The project/grant number is RG1515236103; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That projects N. 33rd St. (ST211220141), N. 38th St. (ST211220145), N. 40th St. (ST211220140), N. 48th St. (ST211220163), N. 50th St. (ST211220143), W. Carmen Ave. (ST211220162), N. Darien St. (ST211220142), W. Lancaster Ave. (ST211220123), N. 61st St. (ST211220167), W. Stark St. (ST211220176), W. Thurston Ave. (ST211220151), N. 29th St. (ST211220154), N. 49th St. (ST211220146), N. 49th St. (ST211220153), N. 56th St. (ST211220150), N. 53rd St. (ST211220195), N. 58th St. (ST211220169), will be billed after January 1, 2024, but not before 12 months after the project contract has been completed.
