THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$180,000 for a total estimated cost of these projects being \$1,549,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$180,000 with the total cost estimated to be \$1,549,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

3rd Aldermanic District and Village of Shorewood

E. Edgewood Ave. - N. Lake Dr. to N. Oakland Ave. (ST216220107) Asphalt pavement resurfacing and replace ADA ramps. (Nonassessable High Impact Paving Fund -- \$15,000). The total estimated cost of this project including the requested amount is \$630,000. This project is anticipated to be completed during the 2023-24 construction season.

E. Lisbon Ave. - W. Burleigh St. to N. 76th St. (SM495220020) Relaying storm sewer.

(Nonassessable Sewer Maintenance Relay Fund - \$20,000). The total estimated cost of this project including the requested amount is \$456,000. This project is anticipated to be completed during the 2023 construction season.

12th Aldermanic District

S.Bettinger Ct. - W. Pierce St. to 170' South of W. Pierce St. (WT410220920) Water main extension. (Nonassessable Water Fund Budget Line 5010 -- \$1,000. Nonassessable Water Fund Budget Line 6410 -- \$14,000). The total estimated cost of this project including the requested amount is \$95,000. This project is anticipated to be completed during the 2023 construction season.

N. 20th St. - W. Center St. to W. Hadley St. (SM495220021) Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund - \$15,000). The total estimated cost of this project including the requested amount is \$218,000. This project is anticipated to be completed during the 2022 construction season.

N. 24th St. - W. Galena St. to W. Walnut St. (WT410220919) Abandoning water main. (Nonassessable Water Fund Budget Line 5010 -- \$1,000. Nonassessable Water Fund Budget Line 6410 -- \$14,000). The total estimated cost of this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2022 construction season.

2022 Speed Hump Construction Administration (ST211220235) (Nonassessable Reconstruction Paving Fund -- \$100,000). The total estimated cost for this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2022 construction season.
