## THE CHAIR

Substitute resolution relative to the acceptance and funding of the 2022-2023 Public Health Preparedness (CDC) Grant from the State of Wisconsin Department of Health Services.

Substitute resolution authorizes the Health Department to accept, and fund the 2022-2023 Public Health Preparedness (CDC) Grant from the State of Wisconsin Department of Health Services in the amount of \$331,934, with a City share of \$0, or 0% and a grantor share of \$331,934, or 100%. The funding will provide support for public health emergency preparedness.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the State of Wisconsin - Department of Health Services to carry out planning, preparation, and evaluation of public health emergency preparedness; and

Whereas, The operation of this grant program from July 1, 2022 to June 30, 2023 will cost \$331,934 comprised of \$331,934, or 100%, grantor share and \$0, or 0%, City share; now, therefore, be it;

Resolved, By the Common Council of the City of Milwaukee, that the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee
