City of Milwaukee*, ERD Case No. CR202100380, cross-filed with EEOC Case No. 26G202100358C; and ERD Case No. CR202201626, cross-filed with EEOC Case No. 26G202201025, for the total amount of \$8,000.00; and

Whereas, Complainant, Norma Lewis filed an ERD charge against the City of Milwaukee, ERD Case No. CR202100382, cross-filed with EEOC Case No. 26G202100358C; and ERD Case No. CR202201626, cross-filed with EEOC Case No. 26G202201025; and

Whereas, Norma Lewis and the City of Milwaukee have entered into an agreement to settle the claims raised by her in the above-referenced matters for the total amount of \$8,000.00; and
