Whereas, Plaintiff filed a lawsuit *John J. Munoz, Jr. v. Michael Anderson, et al.*, Eastern District of Wisconsin, Case No. 18C0495, against Michael Anderson, Robert Velez, and Matthew McGrury seeking damages for alleged violation of federal law and the plaintiff's civil rights; and

Whereas, Plaintiff has agreed to settle the claims raised in the above-referenced lawsuit for the total amount of \$10,000.00, inclusive of all costs and fees, including attorney's fees; and

Further Resolved, that in compliance with the City Attorney's direction, the proper City officers be and hereby are authorized and directed to issue City checks, as soon as practicable in full and final settlement of the claims as outlined in the above-referenced lawsuit, to be charged as follows: to the Damages and Claims Fund, Account No. 636506-0001-1490-2632-S118, in the amount of \$10,000.00 as damages, made payable to John Joseph Munoz, Jr., 815 South 22nd Street, Apt. A, Milwaukee, Wisconsin, 53204; and be it

Further Resolved, that for and in consideration of the above-referenced payments, the Plaintiff will provide to the City a release of claims and a stipulation and proposed order to dismiss the claims raised in the pending court action.
