Whereas, The 2023 Budget was adopted by Common Council File Number 220001 on November 22, 2022; and

Whereas, Amendment 8 to the 2023 Budget placed a footnote in the Budget stating, "This amendment will add a footnote to the Department of City Development to conduct a satisfaction survey of small businesses regarding their experiences working with the Department, and to report the results to the Common Council annually," and

Whereas, According to the Proposed Plan and Budget Summary, one of the objectives of the Department of City Development (DCD) is to "increase commerce and neighborhood vitality in Milwaukee," while one of the Department's strategies is to "Support commercial revitalization efforts using grant and loan programs to catalyze small businesses and improve neighborhood commercial corridors"; and
