THE CHAIR

Resolution relating to acceptance and funding of the 2022-23 Wisconsin Supplemental Nutrition Assistance Program-Education grant from the State of Wisconsin Department of Health services.

This resolution authorizes the Health Department to accept and fund the 2022-23 Wisconsin Supplemental Nutrition Assistance Program-Education Collective Action Initiative grant from the State of Wisconsin Department of Health Services in the amount of \$20,000 with a City share of \$0 and a grantor share of \$20,000. The funding will provide support for a Public Health Strategist position. This position will aid nutrition education programming, community gardens and urban agriculture. The Public Health Strategist will also provide support for healthy food retail in existing and new businesses, city policy, zoning and practice, healthy food financing initiatives, creation of a community commercial kitchen, resident leadership and engagement, as well as other things.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the State of Wisconsin Department of Health to increase access to and consumption of healthy foods; and

Whereas, The operation of this grant program from 10/1/2022 to 9/30/2023 will cost \$20,000 comprised of

\$20,000, or 100% grantor share and \$0, or 0% City share; now, therefore, be it;

Resolved, By the Common Council of the City of Milwaukee, that the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, that the Commissioner of Health or their designee is authorized to execute the grant agreement for these funds; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant parent account of the 2022 Special Revenue-Grant and Aid Projects Fund, the following amounts for the project titled Wisconsin Supplemental Nutrition Assistance Program-Education Collective Action Initiative:

2. Create the necessary Special Revenue Fund Grant and Aid Project/Grant and Project Levels; budget to these Project/Grant values the amounts required under the grant agreement; and be it

Further Resolved, that these funds are budgeted to the Health Department which is authorized to:

1. Expend from the amount appropriated sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
2. Enter into subawards and leases as detailed in the grant budget; and, be it

Further Resolved, That the Common Council directs that the 2023 Positions Ordinance C.C. File Number 220651, should be amended as follows:
