Substitute Resolution relative to acceptance and funding of the 2023 HIV Partner Services Grant from the State of Wisconsin Department of Health Services.

Substitute resolution authorizes the Health Department to accept, and fund the HIV Partner Services grant from the Wisconsin Department of Health Services in the amount of \$504,795 with a City share of \$0 and a grantor share of \$504,795. The funding will provide testing, patient education, and focused disease intervention activities.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Health Services to provide testing, patient education, and focused disease intervention activities; and

Whereas, The operation of this grant program from January 1, 2023 to December 31, 2023 will cost \$504,795 comprised of \$504,795, or 100%, grantor share and \$0, or 0%, City share; now, therefore,

Further Resolved, That the City Comptroller is authorized to:
