THE CHAIR

Substitute resolution relative to the acceptance and funding of the 2023 STD Infertility Prevention Grant from the State of Wisconsin Department of Health Services.

Substitute resolution authorizes the Health Department to accept, and fund the 2023 Sexually Transmitted Disease Assessment, Assurance, Policy Development, and Prevention Strategies (AAPPS) from the Wisconsin Department of Health Services in the amount of \$381,278 with a City share of \$0 and a grantor share of \$381,278. The funding will support reducing the incidence and fertility complications of sexually transmitted diseases in Milwaukee through preventive health education services and focused disease intervention activities.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Health Services to provide disease surveillance, education, testing; and

Whereas, The operation of this grant program from January 1, 2023 to December 31, 2023 will cost \$381,278 comprised of \$381,278, or 100%, grantor share and \$0, or 0%, City share; now, therefore,

Further Resolved, That the City Comptroller is authorized to:
