THE CHAIR

Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$3,923,000 for a total estimated cost of these projects being \$4,067,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$3,923,000. The total estimated cost of these projects is \$4,067,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

1st and 4th Aldermanic Districts

2023 N. 27th St. and W. Highland Blvd. (SM499230003) File Number 221442: Bioretention Maintenance (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$49,000). The total estimated cost of this project is \$50,000. This project is anticipated to be completed during the 2023 construction season.

2nd Aldermanic District

N. 68th St. - W. Grantosa Dr. to 425' South of W. Grantosa Dr. (WT410230642) File Number 211861: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$155,000). The total estimated cost of this project including the requested amount is \$170,000. This project is anticipated to be completed during the 2023 construction season.

This project is anticipated to be completed during the 2023 construction season.

2023 Southside (SM499230002) File Number 221442: Bioretention Maintenance (Storm Water Quality - Nonassessable Water Quality Projects to meet TMDL Requirements -- \$134,000). The total estimated cost of this project is \$135,000. This project is anticipated to be completed during the 2023 construction season.
