The purpose of this grant is to assure readiness for various public health emergencies. Whereas, Common Council File Number 220622 authorized the Health Department to accept and fund the 2022-2023 Public Health Preparedness (CDC) grant for the purpose of carrying out planning, preparation, and evaluation of public health emergency preparedness; and

Whereas, the \$331,934 for this program is increased by \$211,546, and total cost is increased by \$211,546; now, therefore, be it;
