THE CHAIR

A substitute ordinance relating to the change in zoning from Industrial Light, IL2, to Downtown-Mixed Activity, C9G, to allow the development of a museum on the properties located at 1310 and 1340 North 6th Street and 520 West McKinley Avenue, on the east side of North 6th Street between West Vliet Street and West McKinley Avenue, in the 6th Aldermanic District.

This zoning change was requested by Historic Haymarket Milwaukee, Inc. and will allow the development of a museum on the subject sites.

Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. That is added to the Milwaukee Code of Ordinances a new section to read as follows:

The zoning map is amended to change the zoning for 1310 North 6th Street, Tax Key No. 361-0350-100; 1340 North 6th Street, Tax Key No. 361-0348-110; and 520 West McKinley Avenue, Tax Key No. 361-0351-111, from Industrial Light (IL2) to C9G-Downtown Mixed Activity (C9G).
