The limited use standard	s for a tobacco or e-cigarette retailer shall be as follows:
•	rette retailer shall not be within 1,000 feet of an elementary or secondary center, park or playground. If this standard is not met, the use is prohibited.
•	rette retailer shall not be within 500 feet of a premises holding a cigarette his standard is not met, a special use permit is required.
