THE CHAIR

Substitute resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$3,513,000 for a total estimated cost of these projects being \$4,093,000.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$3,513,000. The total estimated cost of these projects is \$4,093,000.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

2nd Aldermanic District

N. 66th St. - W. Carmen Ave. to W. Bobolink Ave. (WT410230689) File Number 211861: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$230,000). The total estimated cost of this project including the requested amount is \$245,000. This project is anticipated to be completed during the 2023 construction season.

W. Bobolink Ave. - N. 65th St. to N. 68th St. (WT410230691) File Number 211861: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$285,000). The total estimated cost of this project including the requested amount is \$305,000. This project is anticipated to be completed during the 2023 construction season.

W. Carmen Ave. - N. 65th St. to N. 68th St. (WT410230688) File Number 211861: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$355,000). The total estimated cost of this project including the requested amount is \$375,000. This project is anticipated to be completed during the 2023 construction season.

The total estimated cost of this project including the requested amount is \$234,000. This project is anticipated to be completed during the 2023 construction season.

This project is anticipated to be completed during the 2023 construction season.

This project is anticipated to be completed during the 2023 construction season.

W. Burdick Ave. - W. River Bend Dr. to S. 75th St. (WT410230680) File Number 211861: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$280,000). The total estimated cost of this project including the requested amount is \$300,000. This project is anticipated to be completed during the 2023 construction season.

W. River Bend Dr. - W. Burdick Ave. to W. Honey Creek Dr. (WT410230681) File Number 211861: Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$0. Nonassessable Water Fund Budget Line 6410 -- \$85,000). The total estimated cost of this project including the requested amount is \$100,000. This project is anticipated to be completed during the 2023 construction season.

W. Walker St. - S. 5th St. to S. 6th St. (SM495220053) File Number 221123: Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund --\$101,000). The total estimated cost of this project including the requested amount is \$113,000. This project is anticipated to be completed during the 2023 construction season.

S. 9th Pl. - W. Montana St. to W. Oklahoma Ave. (SM495220054) File Number 221123: Relaying combined sewer and installing new storm sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$353,000). The total estimated cost of this project including the requested amount is \$368,000. This project is anticipated to be completed during the 2023 construction season.

S. Illinois Ave. - 255'+/- North of E. Holt Ave. to E. Morgan Ave. (SM495220062) File Number 221442: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$297,000). The total estimated cost of this project including the requested amount is \$309,000. This project is anticipated to be completed during the 2023 construction season.

E. Malvern PI. - S. Kinnickinnic Ave. to S. Pennsylvania Ave. (SM495220063) File Number 221442: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$140,000). The total estimated cost of this project including the requested amount is \$152,000. This project is anticipated to be completed during the 2023 construction season.

S. Pennsylvania Ave. - E. Ohio Ave. to E. Holt Ave. (SM495220061) File Number 221442: Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$199,000). The total estimated cost of this project including the requested amount is \$211,000. This project is anticipated to be completed during the 2023 construction season.
