E. North Ave. - N. Bremen St. to N. Booth St. (ST211230141) File Number 230423: Install concrete traffic calming speed table. (Assessable Reconstruction Paving Fund - \$7,600; Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$30,000. This project is anticipated to be completed during the 2024 construction season.

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved That a portion of the traffic calming projects will be utilizing ARPA (American Rescue Plan Act) funds: The project/grant number is RG1515236108; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That projects N. Maryland Ave. ST211230149), E. North Ave. (ST211230141) will be billed after January 1, 2026, but not before 12 months after the project contract has been completed and, be it

Further Resolved, That the following projects be deleted from the 2024 Paving Program: Alley betw. W. Fiebrantz Ave., W. Hope Ave., N. 70th St., N. 71st St. (ST212230102)
