A substitute ordinance relating to a change in zoning from Multi-Family Residential to Two-Family Residential, on land located East of North 25th Street and North of West State Street, in the 4th Aldermanic District. This substitute ordinance changes the zoning for existing residential properties to be consistent with the Near West Side Area Comprehensive Plan. Resolved, That the Mayor and Common Council of the City of Milwaukee, do ordain as follows:

Part 1. There is added to the Milwaukee Code of Ordinances, a new section to read as follows:
