This resolution authorizes City execution of an Amendment to the original Agreement between the City of Milwaukee and the Milwaukee Metropolitan Sewerage District regarding the District's Western Milwaukee Phase 2B Flood Management Project, in the 10<sup>th</sup> and 15<sup>th</sup> Aldermanic Districts, this Amendment includes, among other things, modifications to and replacement of a City-owned retaining wall along the Menomonee River.

Whereas, the purpose of this Amendment is to design and construct a replacement section of retaining wall along the northern bank of the Menomonee River between North 46<sup>th</sup> Street and North 47<sup>th</sup> Street; and

Whereas, The City desires to cooperate with Milwaukee Metropolitan Sewerage District to facilitate implementation of the Project; and

Whereas, this Amendment describes the individual responsibilities of the District and the City with respect to the Project; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the proposed Amendment to the Agreement is hereby approved, and the appropriate City officers and employees, including the Commissioner of Public Works, are hereby authorized to sign the Amendment, or one in substantially the same form and substance as
