THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$1,824,000 for a total estimated cost of these projects being \$15,617,000. This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$1,824,000 with the total cost estimated to be \$15,617,000. Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st Aldermanic District

W. Villard Ave. (North Side) - N. Hopkins St. to N. Sherman Blvd. (WT410250626) Relaying water main and lead replacement of service. (Nonassessable Water Fund Budget Line 5010 -- \$1,000. Nonassessable Water Fund Budget Line 6410 -- \$24,000). The total estimated cost of this project including the requested amount is \$270,000. This project is anticipated to be completed during the 2025 construction season.

2nd Aldermanic District

N. 76th St. - W. Bobolink Pl. to 120' North of W. Florist Ave. (WT410250601) Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$1,000. Nonassessable Water Fund Budget Line 6410 -- \$19,000). The total estimated cost of this project including the requested amount is \$160,000. This project is anticipated to be completed during the 2025 construction season.

W. Florist Ave. - N. 76th St. to N. 77th St. (WT410250602) Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$1,000. Nonassessable Water Fund Budget Line 6410 -- \$19,000). The total estimated cost of this project including the requested amount is \$115,000. This project is anticipated to be completed during the 2025 construction season.

N. 92nd St. - W. Chambers St. to W. Burleigh St. (WT410250620) Relaying water main and lead replacement of service. (Nonassessable Water Fund Budget Line 5010 -- \$1,000. Nonassessable Water Fund Budget Line 6410 -- \$24,000). The total estimated cost of this project including the requested amount is \$250,000. This project is anticipated to be completed during the 2025 construction season.

W. Chambers St. - N. 88th St. to N. 92nd St. (WT410250622) Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$1,000. Nonassessable Water Fund Budget Line 6410 -- \$34,000). The total estimated cost of this project including the requested amount is \$475,000. This project is anticipated to be completed during the 2025 construction season.

W. Locust St. - N. 89th St. (East Line) to N. 92nd St. (WT410250621) Relaying water main. (Nonassessable Water Fund Budget Line 5010 -- \$1,000. Nonassessable Water Fund Budget Line 6410 -- \$29,000). The total estimated cost of this project including the requested amount is \$365,000. This project is anticipated to be completed during the 2025 construction season.

This project is anticipated to be completed during the 2025 construction season.
