Resolution relating to acceptance and funding of a NACCHO-Trauma Proximity Data Grant from the Centers for Disease Control and Prevention.

This resolution authorizes the Fire Department to accept and fund the NACCHO-Trauma Proximity Data Grant from the Centers for Disease Control and Prevention in the amount of \$46,294.00. The purpose of the project is to develop a cross referencing tool for Milwaukee Fire Department (MFD) 911 incidents and Milwaukee Public School (MPS) student's home addresses. This will allow MPS to provide counseling and support services at schools where students may have been impacted by a traumatic event

Whereas, Under the terms of CFDA/AL Program #93.421, The City of Milwaukee appears to be eligible for grant funds from the Centers of Disease Control and Prevention to provide development of a data sharing tool; and

Whereas, The operation of this grant project from 2/1/2024 to 7/31/2024 would cost \$46,294.00 entirely provided by the grantor; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the application to the Centers for Disease Control and Prevention is authorized and the Fire Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it
