SUBSTITUTE 1

THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$613,000 for a total estimated cost of these projects being \$12,080,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$613,000 with the total cost estimated to be \$12,080,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

1st Aldermanic District

W. Villard Ave. - N. 27th St. to N. Teutonia Ave. (SM495100092): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$346,000. This project is anticipated to be completed during the 2011 construction season.

N. 24th St. - W. Purdue St. to 108 feet m/l north of W. Purdue St. (SM495100085): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for

this project including the requested amount is \$102,000. This project is anticipated to be completed during the 2011 construction season.

N. 32nd St. - 300 feet m/l south of W. Villard Ave. to 200 feet m/l south of W. Villard Ave. (SM495100081): Relaying sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$74,000. This project is anticipated to be completed during the 2011 construction season.

N. 34th St. - W. Hopkins St. to W. Capitol Dr. (SM495100069): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$170,000. This project is anticipated to be completed during the 2011 construction season.

N. 70th St. - W. Villard Ave. to W. Leon Terr. (SM495100062): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$64,000. This project is anticipated to be completed during the 2010 construction season.

E. Concordia Ave. - N. Bremen St. to N. Humboldt Ave. (SM495100108): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$420,000. This project is anticipated to be completed during the 2011 construction season.

N. Farwell Ave. - E. Bradford Ave. to E. Belleview PI. (SM495100118): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$219,000. This project is anticipated to be completed during the 2011 construction season.

4th Aldermanic District

W. Clybourn St. - N. 6th St. to N. 7th St. (SM495100115): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$95,000. This project is anticipated to be completed during the 2011 construction season.

E. Wisconsin Ave. - N. Water St. to N. Broadway (SM495100125): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$150,000. This project is anticipated to be completed during the 2011 construction season.

N. 15th St. - W. Wisconsin Ave. to W. State St. (SM495100066): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$497,000. This project is anticipated to be completed during the 2011 construction season.

N. 34th St. - W. Vliet St. to W. Cherry St. (SM495100135): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this

project including the requested amount is \$142,000. This project is anticipated to be completed during the 2011 construction season.

W. Galena St. - N. 34th St. to N. 35th St. (SM495100121): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). W. Villard Ave. - N. 105th St. to N. 107th St. (SM495100109): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$59,000. This project is anticipated to be completed during the 2010 construction season.

N. 23rd St. - W. Chambers St. to W. Burleigh St. (SM495100086): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$250,000. This project is anticipated to be completed during the 2011 construction season.

W. Bernhard Pl. - N. 42nd St. to N. Sherman Blvd. (SM495100114): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2011 construction season.

W. Chambers St. - N. 22nd St. to N. 23rd St. (SM495100123): Relaying combined sewer.

(Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$261,000. This project is anticipated to be completed during the 2011 construction season.

N. 22nd St. - W. Locust St. to W. Chambers St. (SM495100087): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000).
