Whereas, The Health Department received an objection from Ald. Willie Hines, Jr. to a food dealer license for Adli Dahadha, Agent for Atari Food, LLC, for the premises at 2478 N. 38<sup>th</sup> Street doing business as "Atari Food, LLC" in the 15th Aldermanic District; and

The Common Council's Licenses Committee held an evidentiary hearing on the application on July 12, 2010; and

The Committee heard neighborhood testimony in opposition to the license and saw evidence of over concentration of food dealer outlets in the area; now, therefore,

It is moved, by the Common Council of the City of Milwaukee, that the food dealer license application
