Whereas, The Common Council adopted Resolution File Number 991882 on April 11, 2000, approving a 5-year lease agreement with Voicestream Wireless for the placement of personal communications services antennas at the Zeidler Municipal Building; and

Whereas, The Department of Administration has been working with the Department of Public Works and the City Attorney's Office to negotiate an amendment extending the lease agreement; and

Whereas, This agreement provides a 5-year extension of the lease agreement between the City and Voicestream Wireless for the placement of personal communications services antennas at the Zeidler Municipal Building; and
