Whereas, The 2025 Adopted Budget provided \$70,000 to the MKE Community Excellence Fund Special Purpose Account; and

Whereas, Carryover funds totaling \$35,372.60 are available from the 2024 Adopted Budget; and

Whereas, The purpose of the MKE Community Excellence Fund Special Purpose Account is to provide resources to support community events that promote peace and violence prevention, with the intention that allocations from the SPA will be matched by contributions from local organizations; and

Whereas, The events and initiatives receiving allocations of funding under this resolution all provide opportunities for the City to support the promotion of peace and the prevention of violence, in alignment with the intended purpose of the MKE Community Excellence Fund; now, therefore, be it

Resolved, by the Common Council of the City of Milwaukee, that the City Clerk is directed to expend up to \$105,372 from the MKE Community Excellence Fund Special Purpose Account (0001 1310
