Resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$519,000 for a total estimated cost of these projects being \$3,665,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$519,000 with the total cost estimated to be \$3,665,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

3rd Aldermanic District

N. Maryland Ave. - N. Prospect Ave. to a point of N. Prospect Ave. (ST211100161): Concrete curb and gutter. (Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$36,000. This project is anticipated to be completed during the 2010 construction season.

E. North Ave. Sink Hole (SM495100160): (Nonassessable Sewer Maintenance Relay Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$1,000,000. This

project is anticipated to be completed during the 2010 construction season.

4th Aldermanic District

N. Commerce St. - N. Fratney St. to N. Holton St. (SM495100152): Combined sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$1,415,000. This project is anticipated to be completed during the 2010 construction season.

E. Kilbourn Ave. at N. Prospect Ave. (ST211100160): Median revision. (Nonassessable Reconstruction Paving Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$14,000. This project is anticipated to be completed during the 2011 construction season.

15th Aldermanic District

N. 26th St. at W. Vine St. (SM495100154): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$1,000). The total estimated cost for this project including the requested amount is \$700,000. This project is anticipated to be completed during the 2010 construction season.

City Wide

2010 Sewer Structure Construction and Rehabilitation (SM495100153): (Nonassessable Sewer Maintenance Relay Fund -- \$500,000). The total estimated cost for this project is \$500,000. This project is anticipated to be completed during the 2010 construction season; and, be it

Further Resolved, That all City Departments are authorized to perform engineering, surveys, plan preparation, and determine an estimated cost thereof; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
