Further Resolved, That after December 22, 2010, and upon receipt of said property tax bill from the City Treasurer, the City Comptroller shall issue to the City Treasurer a check in the amount of \$347.34 for NF000838 to pay the 1st installment of said special assessments, and that following the issuance of the check, the deferred special assessments shall be processed in the manner specified in File Number 74-1975: and, be it

Further Resolved, That a six-year total of \$1,966.54 shall be deferred; and, be it

Further Resolved, That said Comptroller is also authorized to expend a sum equal to the recording fees in excess of the amounts deferred.
