Current code provisions require that any maintenance or repairs on tax deed property that exceed the sum of \$1,000 shall be submitted to the common council for its approval. This ordinance repeals that provision. Furthermore, this ordinance places the operation, maintenance and repair of tax deed property under the functions, powers and duties of the department of city development. This

308-1. Department of City Development. 2. FUNCTIONS, POWERS AND DUTIES. m. To attend to the operation, maintenance and repair of improvements upon land acquired by tax deed by the city in order that the premises may be rented and kept rented until sold, otherwise disposed of or appropriated.
