Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$638,300 for a total estimated cost of these projects being \$3,838,300.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$638,300 with the total cost estimated to be \$3,838,300.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

# 4th Aldermanic District

N. Plankinton Ave. - W. Wisconsin Ave. to W. Wells St. (SM495110509): Sewer work prior to paying

Contract C523110023. (Nonassessable Sewer Maintenance Relay Fund -- \$14,200). The total estimated cost for this project is \$14,200. This project is anticipated to be completed during the 2011 construction season.

# 5th Aldermanic District

- W. Keefe Ave. N. 84th St. to W. Lisbon Ave. (SM495110503): Sewer work prior to paving Contract C523110032. (Nonassessable Sewer Maintenance Relay Fund -- \$52,000). The total estimated cost for this project is \$52,000. This project is anticipated to be completed during the 2011 construction season.
