A substitute ordinance relating to amending aldermanic district boundaries commencing in 2012. 301-2 rc

This ordinance lists those election wards which are assigned to each of the 15 aldermanic districts commencing in 2012. This file utilizes wards as amended through file number 110474, based on the establishment of Wisconsin State Legislature boundaries.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 301-2 of the code is repealed and recreated to read:

**301-2. Aldermanic District Boundaries.** Effective with the 2012 spring primary election, the territory within the limits of the city of Milwaukee shall be divided into 15 aldermanic districts which shall be comprised of the following election wards, as described in resolution file number 110474:
