THE CHAIR

A substitute ordinance relating to traffic controls.

This ordinance establishes the above-mentioned traffic requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-10-2 of the Code relating to No Right Turns on Red Signal is amended by striking the following:

"On North 13th Street at West Wisconsin Avenue (southbound)"

Part 2. Section 101-16-1 of the Code relating to Stop signs is amended by striking the following:

"On West Branting Lane at South 36th Street"

Part 3. Section 101-16-1 of the Code relating to Stop signs is amended by adding the following:

On South Nevada Avenue at East Manitoba Street

On West Rohr Avenue and North 33rd Street in all directions

On West Pierce Street and South 24th Street in all directions

On West Branting Lane and South 36th Street in all directions

On West Hayes Avenue and South 9th Place in all directions

Part 4. Section 101-18-1 of the Code relating to No Heavy Traffic is amended by adding the following:

On West Green Tree Road at North 107th Street (westbound)

On East Pryor Avenue at South Clement Avenue (eastbound)
