Whereas, The Charter School Review Committee requests approval of a vendor contract with the Children's Research Center for educational oversight services provided to the committee; and

Whereas, Under this contract, the Children's Research Center will provide the City with the following services for each of the City's chartered schools:

- 1. Complete fall and spring interviews with the school's leadership.
- 2. Conduct at least 2 site visits at each school.
- 3. Facilitate the completion of a learning memo and provide a data addendum as needed.
- 4. Provide continuous follow-up and support to each school as needed.
- 5. Collect and analyze the data that are submitted by the school.
- 6. Produce a draft and final edition of an annual monitoring report.
