THE CHAIR

A substitute ordinance relating to traffic controls in various Aldermanic Districts.

This ordinance establishes the above-mentioned traffic requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-9-1 of the Code relating to Designation of Prohibited Pedestrian Crossings is amended by adding the following:

The west crosswalk at the intersection of North James Lovell Street and West State Street

Part 2. Section 101-10-2 of the Code relating to No Right Turns on Red Signal is amended by adding the following:

On West State Street at North James Lovell Street eastbound

Part 3. Section 101-11-1 of the Code relating to No Left Turn is amended by striking the following:

"On West Layton Avenue at the first median opening eastbound on West Layton Avenue east of South 6th Street"

Part 4. Section 101-12-2 of the Code relating to No U-Turns is amended by adding the following:

On West Capitol Drive at the median opening west of North 27th Street from 10:00 PM to 5:00 AM eastbound and westbound

On West Capitol Drive at North 28th Street from 10:00 PM to 5:00 AM eastbound and westbound

On West Capitol Drive at North 29th Street from 10:00 PM to 5:00 AM eastbound and westbound

On West Capitol Drive at North 30th Street from 10:00 PM to 5:00 AM eastbound and westbound

On West Capitol Drive at the median opening east of North 31st Street from 10:00 PM to 5:00 AM eastbound and westbound

On West Capitol Drive at the median opening east of North 34th Street from 10:00 PM to 5:00 AM eastbound and westbound

On North 51st Street at the median opening north of West Fond du Lac Avenue from 10:00 PM to 5:00 AM northbound and southbound

On North 51st Street at the median opening north of West Hope Avenue from 10:00 PM to 5:00 AM northbound and southbound

On North 51st Street at West Marion Street from 10:00 PM to 5:00 AM northbound and southbound

"On South 34th Street at West Grant Street

Part 6. Section 101-16-1 of the Code relating to Stop signs is amended by adding the following:

On South 5th Place at West Burnham Street

On West Ring Street and North 9th Street in all directions

On West Grant Street and South 34th Street in all directions

On West Becher Street and South 34th Street in all directions
