## THE CHAIR

A substitute ordinance relating to parking controls in various Aldermanic Districts. This ordinance establishes the above-mentioned parking requirements in various parts of the City.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-23-3 of the Code relating to No Parking is amended by striking the following:

"On the west side of South 38th Street from the north curb line of West Mitchell Street to a point 400 feet north thereof from 7:00 AM to 9:00 AM and from 3:30 PM to 5:30 PM except Saturday and Sunday"

Part 2. Section 101-23-3 of the Code relating to No Parking is amended by adding the following:

On the north side of East Pleasant Street from North Cass Street to North Marshall Street

On the south side of West State Street from North 12th Street to a point 75 feet west

On the north side of West Locust Street from North 54th Street to a point 40 feet east

On the south side of West Locust Street from North 54th Street to a point 40 feet west

On the north side of West Becher Street from South 25th Street to a point 40 feet east

On the south side of West Becher Street from South 25th Street to a point 40 feet west

On the south side of West Pierce Street from South 20th Street to a point 50 feet west

On the south side of West Potawatomi Circle from South 19th Street to a point 400 feet west

On the east side of North Industrial Road from a point 2,895 feet north of West Mill Road to a point 155 feet north thereof

On the west side of South 27th Street from West Ohio Avenue to West Morgan Avenue

On the south side of West Pierce Street from South 20<sup>th</sup> Street to a point 50 feet west On the north side of East Estes Street from South Superior Street to South Shore Drive

On the east side of S. 9th Place from West Haves Avenue to a point 70 feet south

Part 3. Section 101-23-4-c of the Code relating to One-Hour Parking is amended by striking the following:

"On the west side of North 19<sup>th</sup> Street from West Wisconsin Avenue to West Wells Street from 7:00 AM to 7:00 PM except Sunday and except where No Parking is in effect"

Part 4. Section 101-23-4-d of the Code relating to Two-Hour Parking is amended by adding the following:

On North 9th Street from West State Street to West Highland Avenue from 8:00 AM to 6:00 PM Saturday

On the west side of North 19th Street from West Wisconsin Avenue to West Wells Street

On the south side of West Brown Street from North Dr. Martin L. King Jr. Dr. west to the alley

On the east side of South 27th Street from West Ohio Avenue to a point 140 feet north

On south side of East Pittsburgh Avenue from South 1st Street to South Water Street

Part 5. Section 101-23-4-e of the Code relating to Three-Hour Parking is amended by striking the following:

"On South 38th Street from West Mitchell Street to West Greenfield Avenue from 7:00 AM to 7:00 PM except Sunday"

Part 6. Section 101-26-5-1-b of the Code relating to Snow Parking Regulations - Four or More Inches is amended by adding the following:

On the east side of South 24th Street from West Orchard Street to West Lapham Street

Part 7. Section 101-27-9 of the Code relating to Night Parking Exceptions is amended by adding the following:

On North 85th Street from West Beatrice Court to West Fairy Chasm Drive

Part 8. Section 101-32-3-d-4 of the Code relating to Two-Hour Meter Parking is amended by adding the following:

On North 9<sup>th</sup> Street from West State Street to West Highland Avenue from 8:00 AM to 6:00 PM Monday through Friday
