Substitute resolution to grant a special privilege to Market Street Partners II LLP to place a covered walk and to keep, use and maintain 9 brackets for civic interest flags all encroaching into the east side of North Water Street within the public right-of-way at 1114 North Water Street, in the 4th Aldermanic District in the City of Milwaukee.

This special privilege grants Market Street Partners II LLP permission to place a covered walk and to keep, use and maintain 9 brackets for civic interest flags all encroaching into the east side of North Water Street within the public right-of-way at 1114 North Water Street.

Whereas, The applicant desires to place and maintain a covered walk at 1114 North Water Street that will encroach into the public right-of-way; and

Whereas, Our field investigation revealed that there are brackets attached to the building that have been and still are intended to be used for civic interest flags; and

Whereas, Said covered walk and brackets and flags may only legally occupy the public right-of-way by the granting of a special privilege resolution by the Common Council; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that Market Street Partners II LLP Attn. John Silseth, 322 East Michigan Street, STE 275, Milwaukee, WI 53202, is hereby granted the following special privileges:

1. To keep and maintain a covered walk at the property known as 1114 North Water Street. Said covered walk, 6 feet in width, is centered approximately 140 feet south of the southline of West Juneau Avenue and encroaches approximately 9 feet 7 inches into the 12-foot wide sidewalk area on the east side of North Water Street at the 1114 North Water Street address. The covered walk is proposed to be supported by the building and by two vertical supports near each corner closest to the curb along each side of the covered walk. Each vertical support is centered approximately 2 feet east of the present curbline. The vertical clearance between the skirt of the covered walk and the sidewalk below is approximately 8 feet 6 inches.

Said covered walk shall generally be constructed in accordance with the policies set forth in Common Council Resolution File Number 62-1211-a, adopted July 24, 1962. The covered walk frame shall be designed and supported to withstand snow and other loads of not less than 25 pounds per square foot and wind pressure of 20 pounds per square foot applied in any direction. No guy wires, brackets or diagonal braces shall be permitted lower than 8 feet above the sidewalk level. The covering shall be of approved material.

2. To keep, use and maintain nine brackets and flags of civic interest attached to the building at 1114 North Water Street encroaching at a height of at least 12 feet above sidewalk grade. All fixtures and materials for illumination of covered walk shall be indicated upon the construction plans and approved prior to installation.

No sign or advertising device shall be hung from, attached to, printed or painted on any part of the covered walk. The name, street number, or character of the business may be indicated only on the vertical portion of the covering and shall not exceed 6 inches in height.

The grantee will be required to keep a "Loading Zone" or have a "No Parking" status adjacent to the covered walk as long as the covered walk occupies the public right-of-way.

Said covered walk shall be constructed, installed, maintained and used to the approval of the Departments of Public Works and Neighborhood Services

; and, be it

Further Resolved, That this special privilege is granted only on condition that by acceptance of this special privilege the grantee, Market Street Partners II LLP, shall:

- 1. Become primarily liable for damages to persons or property by reason of the granting of this special privilege.
- 2. File with the City Clerk a bond of a surety company duly incorporated in the State of Wisconsin, or duly licensed to do business in this State, in the sum of \$1,000.00 such bond to be approved by the City Attorney. The applicant shall also file with the City Clerk a certificate of insurance indicating applicant holds a public liability policy in the sum of at least \$50,000 covering bodily injury to any one person and \$10,000 covering bodily injury to more than one person in any one accident and \$10,000 covering property damage to any one owner on the area or areas included within the special privilege and naming the City of Milwaukee as an insured. Both bond and insurance policy shall provide that they shall not be canceled until after at least thirty days' notice in writing to the City Clerk.
- 3. Pay to the City Treasurer an annual fee which has an initial amount of \$210.00. The subsequent annual fee is subject to change pursuant to the annual fee schedule in effect at the time of annual billing.
- 4. Whenever this special privilege is discontinued for any reason whatsoever, including public necessity whenever so ordered by resolution adopted by the Common Council not only remove all construction work executed pursuant to this special privilege, but shall also restore to its former condition and to the approval of the Commissioner of Public Works any curb, pavement or other public improvement which was removed, changed or disturbed by reason of the granting of this special privilege. Such grantee shall be entitled to no damages due to the alteration and/or removal for such purposes.
- 5. Waive the right to contest in any manner the validity of Section 66.0915(3) of the Wisconsin Statutes (1999), or the amount of the annual fixed fee, payable on or before July 1st of each year.
- 6. Put this special privilege into use within one year after approval by the Common Council of the City of Milwaukee; failing to do so in the time specified, the Commissioner of the Department of Neighborhood Services shall have the authority to seek, by resolution, revocation of said special privilege.
