Substitute ordinance to further amend the 2003 offices and positions in the City Service under control of the Common Council.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 1 of ordinance File Number 020487 relative to offices and positions in the City Service is hereby amended as follows:

Under "Health Department, Home Environmental Health Division, Pilot Ordinance Evaluation Grant(H)", delete one position of "Health Assistant II(X)(H)"; under "Lead Hazard Reduction Grant(D)", delete one position of "Health Assistant II(0.5 FTE)(D)(X)" and add one position of "Health Assistant II(D)(H)(X)", amend footnote "(H)" as follows: "To expire 03/31/04 unless the Pilot Ordinance Evaluation Grant, available from the Batelle Organization, is extended. Also funds 0.5 FTE of Public Health Aide position under the Lead Hazard Reduction Grant" and amend footnote "(D)" as follows: "To expire 05/15/05 unless the Lead Hazard Reduction Grant, available from the U.S. Department of Housing and Urban Development, is extended. 0.5 FTE of the Lab Assistant position funded by the CDBG Lead Grant and 0.5 FTE of the Public Health Aide funded by the Pilot Ordinance Evaluation Grant"; under "Childhood Lead Poisoning Prevention Program(W)", delete one position of "Office Assistant II(W)" and amend footnote "(W)" as follows: "To expire 06/30/04 unless the Childhood Lead Poisoning Prevention Grant, available from the State of Wisconsin Division of Health and Family Services, is extended"; under "Health Access and Adult Health, Coordinated Community Response Grant (EE) " amend footnote "(EE)" as follows: "To expire 06/30/04 unless the Coordinated Community Response Grant is extended"; under "Milwaukee Breast Cancer Awareness Program", add one position of "Radiological Technician (KK) (X) " and amend footnote "(KK)" as follows: "To expire 12/31/03 unless the Cancer Control Coordination Grant is extended"; under "School Based Medical Assistance Outreach Grant (CC) ", delete one position of "Health Access Assistant II (CC) (X) (LL) " and add one position of "Health Access Assistant II(CC)(X)" and delete footnote "(LL)" in its entirety.

- Part 2. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.
- Part 3. The provisions of this ordinance are deemed to be in force and effect from and after the first day of the first pay period following passage and publication.
- Part 4. This ordinance will take effect and be in force from and after its passage and publication.
