A substitute ordinance relating to parking controls on West Mitchell Street and various intersecting streets.

This ordinance eliminates meter parking on Saturdays along West Mitchell Street between S. 6<sup>th</sup> Street and S. 13<sup>th</sup> Street and portions of various intersecting streets. Saturday parking in these locations will continue to be subject to the time limitations previously in force under the meter parking system.

The Mayor and Common Council of the City of Milwaukee do ordain as follows:

Part 1. Section 101-23-4-c of the code relating to one-hour parking is amended by adding the following:

On the east side of South 7<sup>th</sup> Street from West Mitchell Street to a point 150 feet north from 9:00 AM to 6:00 PM on Saturday

On South 8<sup>th</sup> Street from West Mitchell Street to a point 120 feet north from 8:00 AM to 6:00 PM on Saturday

On South 8<sup>th</sup> Street from West Mitchell Street to a point 120 feet south from 8:00 AM to 6:00 PM on Saturday

On South 10<sup>th</sup> Street from West Mitchell Street to a point 120 feet north from 8:00 AM to 6:00 PM on Saturday

On South 10<sup>th</sup> Street from West Mitchell Street to a point 120 feet south from 8:00 AM to 6:00 PM on Saturday

On the east side of South 11<sup>th</sup> Street from West Mitchell Street to a point 120 feet south from 9:00 AM to 6:00 PM on Saturday

On the west side of South 11<sup>th</sup> Street from W. Mitchell Street to West Maple Street from 9:00 AM to 6:00 PM on Saturday

On the west side of South 11<sup>th</sup> Street from a point 120 feet north of West Mitchell Street to a point 140 feet further north from 9:00 AM to 6:00 PM on Saturday

On South 12<sup>th</sup> Street from West Mitchell Street to a point 120 feet north from 9:00 AM to 6:00 PM on Saturday

On South 13<sup>th</sup> Street from West Forest Home Avenue to West Maple Street from 9:00 AM to 6:00 PM on Saturday

Part 2. Section 101-23-4-d of the code relating to 2-hour parking is amended by adding the following:

On the east side of South 9<sup>th</sup> Street from West Mitchell Street to a point 120 feet north from 8:00 AM to 6:00 PM on Saturday

On the west side of South 9<sup>th</sup> Street from West Mitchell Street to a point 200 feet north from 8:00 AM to 6:00 PM on Saturday

On the east side of South 9<sup>th</sup> Street from West Mitchell Street to a point 120 feet south from 8:00 AM to 6:00 PM on Saturday

On South 12<sup>th</sup> Street from West Mitchell Street to a point 260 feet south from 8:00 AM to 6:00 PM on Saturday

On the south side of West Forest Home Avenue from West Mitchell Street to South 13<sup>th</sup> Street from 8:00 AM to 6:00 PM on Saturday

On West Mitchell Street from South 6<sup>th</sup> Street to South 12<sup>th</sup> Street from 8:00 AM to 6:00 PM on Saturday

On the north side of West Mitchell Street from South 12<sup>th</sup> Street to South 13<sup>th</sup> Street from 8:00 AM to 6:00 PM on Saturday

On the south side of West Mitchell Street from South 12<sup>th</sup> Street to West Forest Home Avenue from 8:00 AM to 6:00 PM on Saturday

Part 3. Section 101-32-3-c-1 of the code relating to one-hour meter parking is amended by striking the following:

"S. 10<sup>th</sup> Street from the north curb line of W. Mitchell Street north to the south line of the first east-west alley north of W. Mitchell Street, from 9 A.M. to 6 P.M., except on Friday from 9 A.M. to 9 P.M."

"On the east side of S. 10<sup>th</sup> Street from the south curb line of W. Mitchell Street to a point approximately 150 feet south thereof, from 9 A.M. to 6 P.M., except on Friday from 9 A.M. to 9 P.M."

"On the west side of S. 10<sup>th</sup> Street from the south curb line of W. Mitchell Street south to the north line of the east-west alley south of W. Mitchell Street, from 9 A.M. to 6 P.M., except on Friday from 9 A.M. to 9 P.M."

Part 4. Section 101-32-3-c-2 of the code relating to one-hour meter parking is amended by adding the following:

On the east side of South 7<sup>th</sup> Street from West Mitchell Street to a point 150 feet north from 9:00 AM to 6:00 PM Tuesday through Thursday, Monday and Friday to 9:00 PM

On South 8<sup>th</sup> Street from West Mitchell Street to a point 120 feet north from 8:00 AM to 6:00 PM Tuesday through Thursday, Monday and Friday to 9:00 PM

On South 8<sup>th</sup> Street from West Mitchell Street to a point 120 feet south from 8:00 AM to 6:00 PM Monday through Friday

On South 10<sup>th</sup> Street from West Mitchell Street to a point 120 feet north from 8:00 AM to 6:00 PM Monday through Friday

On South 10<sup>th</sup> Street from West Mitchell Street to a point 120 feet south from 8:00 AM to 6:00 PM Monday through Friday

On the east side of South 11<sup>th</sup> Street from West Mitchell Street to a point 120 feet south from 9:00 AM to 6:00 PM Monday through Thursday, Friday to 9:00 PM

On the west side of South 11<sup>th</sup> Street from West Mitchell Street to West Maple Street from 9:00 AM to 6:00 PM Monday through Thursday, Friday to 9:00 PM

On the west side of South 11<sup>th</sup> Street from a point 120 feet north of West Mitchell Street to a point 140 feet further north from 9:00 AM to 6:00 PM Monday through Friday

On South 12<sup>th</sup> Street from West Mitchell Street to a point 120 feet north from 8:00 AM to 6:00 PM Monday through Friday

On the east side of South 13<sup>th</sup> Street from West Forest Home Avenue to West Maple Street from 9:00 AM to 6:00 PM Monday through Friday

On the west side of South 13<sup>th</sup> Street from West Forest Home Avenue to West Maple Street from 9:00 AM to 6:00 PM Monday through Thursday, Friday to 9:00 PM

Part 5. Section 101-32-3-c-3 of the code relating to one-hour meter parking is amended by striking the following:

"On the east side of S. 7<sup>th</sup> Street from W. Mitchell Street to a point approximately 150 feet north thereof from 9:00 a.m. to 6:00 p.m. except Sunday"

"On both sides of S. 8<sup>th</sup> Street from a point approximately 120 feet south of W. Mitchell Street to a point approximately 120 feet north of W. Mitchell Street from 9:00 a.m. to 6:00 p.m. except Sunday"

"On both sides of S. 9<sup>th</sup> Street from W. Mitchell Street to a point approximately

200 feet north thereof from 9:00 a.m. to 6:00 p.m. except Sunday"

"On the west side of S. 11<sup>th</sup> Street from W. Mitchell Street to a point approximately 300 feet north thereof from 9:00 a.m. to 6:00 p.m. except Sunday"

"On both sides of S. 11<sup>th</sup> Street from W. Mitchell Street to a point approximately 280 feet south thereof from 9:00 a.m. to 6:00 p.m. except Sunday"

"On both sides of S. 12<sup>th</sup> Street from W. Maple Street to a point approximately 120 feet north of W. Mitchell Street from 9:00 a.m. to 6:00 p.m. except Sunday"

"On both sides of S. 13<sup>th</sup> Street from W. Forest Home Avenue to W. Maple Street from 9:00 a.m. to 6:00 p.m. except Sunday"

Part 6. Section 101-32-3-d-1 of the code relating to 2-hour meter parking is amended by striking the following:

"On the east side of S. 9<sup>th</sup> Street from W. Mitchell Street to a point 120 feet south thereof from 9:00 a.m. to 6:00 p.m. except Sunday"

Part 7. Section 101-32-3-d-2 of the code relating to 2-hour meter parking is amended by striking the following:

"On W. Mitchell Street from S. 6<sup>th</sup> Street to S. 14<sup>th</sup> Street from 8:00 AM to 6:00 PM except Sunday"

Part 8. Section 101-32-3-d-2 of the code relating to 2-hour meter parking is amended by adding the following:

On the east side of South 9<sup>th</sup> Street from West Mitchell Street to a point 120 feet north from 8:00 AM to 6:00 PM Monday through Friday

On the west side of South 9<sup>th</sup> Street from West Mitchell Street to a point 200 feet north from 8:00 AM to 6:00 PM Monday through Friday

On the east side of South 9<sup>th</sup> Street from West Mitchell Street to a point 120 feet south from 8:00 AM to 6:00 PM Monday through Friday

On South 12<sup>th</sup> Street from West Mitchell Street to a point 260 feet south from 8:00 AM to 6:00 PM Monday through Friday

On the south side of West Forest Home Avenue from West Mitchell Street to South 13<sup>th</sup> Street from 8:00 AM to 6:00 PM Monday through Friday

On West Mitchell Street from South 6<sup>th</sup> Street to South 12<sup>th</sup> Street from 8:00 AM to 6:00 PM Monday through Friday

On the north side of West Mitchell Street from South 12<sup>th</sup> Street to South 13<sup>th</sup> Street from 8:00 AM to 6:00 PM Monday through Friday

On the south side of West Mitchell Street from South 12<sup>th</sup> Street to West Forest Home Avenue from 8:00 AM to 6:00 PM Monday through Friday

Part 9. Section 101-32-3-d-3 of the code relating to 2-hour meter parking is amended by striking the following:

"On the south side of W. Forest Home Avenue from S. 13<sup>th</sup> Street to W. Mitchell Street from 8:00 a.m. to 6:00 p.m. except Sunday"

Part 10. This ordinance shall be effective January 1, 2004.
