SUBSTITUTE 1

THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations and appropriating funds for these purposes with the City engineering cost estimated to be \$1,483,000 for a total estimated cost of these projects being \$13,262,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$1,483,000 with the total cost estimated to be \$13,262,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:

### 3rd Aldermanic District

E. Bradford Ave. - N. Downer Ave. to N. Wahl Ave. (SM495070110): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$181,000. This project is anticipated to be completed during the 2008 construction season.

N. Downer Ave. - E. Locust St. to E. Kenwood Blvd. (SM495070103): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$421,000. This project is anticipated to be completed during the 2008 construction season.

N. Hackett Ave. - E. Newberry Blvd. to E. Kenwood Blvd. (SM495070080): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$500,000. This project is anticipated to be completed during the 2008 construction season.

E. Linnwood Ave. - N. Farwell Ave. to N. Lake Dr. (SM495070104): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$540,000. This project is anticipated to be completed during the 2008 construction season.

N. Maryland Ave. - E. Bradford Ave. to E. Locust St. (SM495070120): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$378,000. This project is anticipated to be completed during the 2008 construction season.

N. Oakland Ave. - E. Irving Pl. to E. Lafayette Pl. (SM495070166): Relaying combined sewer.

(Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$41,000. This project is anticipated to be completed during the 2008 construction season.

N. Summit Ave. - E. Linnwood Ave. to E. Kenwood Blvd. (SM495070121): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$58,000. This project is anticipated to be completed during the 2008 construction season.

N. Terrace Ave. - E. Bradford Ave. to a point 350 feet m/l north of E. Bellevue Pl. (SM495070111): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$244,000. This project is anticipated to be completed during the 2008 construction season.

#### 4th Aldermanic District

N. 25th St. - W. Michigan St. to a point 230 feet m/l north of W. Michigan St. (SM495070126): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$55,000. This project is anticipated to be completed during the 2008 construction season.

#### 5th and 10th Aldermanic Districts

N. 75th St. - W. Chambers St. to W. Locust St. (SM495070135): Relaying sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$324,000. This project is anticipated to be completed during the 2008 construction season.

#### 6th Aldermanic District

W. Auer Ave. - N. Julia St. to N. 5th St. (SM495070164): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$44,000. This project is anticipated to be completed during the 2008 construction season.

N. Booth St. - E. Concordia Ave. to E. Keefe Ave. (SM495070168): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$112,000. This project is anticipated to be completed during the 2008 construction season.

N. Julia St. - W. Burleigh St. to W. Ring St. (SM495070165): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$21,000). The total estimated cost for this project including the requested amount is \$280,000. This project is anticipated to be completed during the 2008 construction season.

N. 5th St. - W. Hadley St. to W. Chambers St. (SM495070042): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000, additional funds). The total estimated cost for this project including the requested amount is \$626,000. This project is anticipated to be

completed during the 2008 construction season.

N. 7th St. - W. North Ave. to W. Meinecke Ave. (SM495070167): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$131,000. This project is anticipated to be completed during the 2008 construction season.

#### 7th Aldermanic District

W. Melvina St. - N. 46th St. to W. Leon Tr. (SM495070159): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$140,000. This project is anticipated to be completed during the 2008 construction season.

N. 40th St. - A point 75 feet m/l north of W. Roosevelt Dr. to W. Capitol Dr. (SM495070149): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$92,000. This project is anticipated to be completed during the 2008 construction season.

N. 46th St. - W. Center St. to W. Hadley St. (SM495070109): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$53,000. This project is anticipated to be completed during the 2008 construction season.

N. 47th St. - W. Burleigh St. to W. Townsend St. (SM495070150): Sanitary sewer relay. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$616,000. This project is anticipated to be completed during the 2008 construction season.

N. 50th St. - W. Hadley St. to W. Locust St. (WT410081074): Relaying water main. (Nonassessable Water Fund -- \$15,000). The total estimated cost for this project including the requested amount is \$75,000. This project is anticipated to be completed during the 2008 construction season.

N. 50th St. - W. Keefe Ave. to W. Vienna Ave. (SM495070152): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$162,000. This project is anticipated to be completed during the 2008 construction season.

#### 7th and 10th Aldermanic Districts

N. 52nd St. - A point 115 feet m/l north of W. Burleigh St. to a point 220 feet m/l south of W. Concordia Ave. (SM495070153): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$239,000. This project is anticipated to be completed during the 2008 construction season.

#### 8th Aldermanic District

W. Kinnickinnic River Parkway - S. 33rd St. to S. 34th St. (SM495070130): Sanitary sewer relay.

(Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$84,000. This project is anticipated to be completed during the 2008 construction season.

W. Mineral St. - S. 21st St. to a point 150 feet m/l west of S. 21st St. (SM495070071): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$36,000. This project is anticipated to be completed during the 2008 construction season.

S. 34th St. - W. Kinnickinnic River Parkway to W. Montana St. (SM495070147): Sanitary sewer relay. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$266,000. This project is anticipated to be completed during the 2008 construction season.

#### 10th Aldermanic District

N. Avondale Blvd. - W. Lisbon Ave. to W. Center St. (SM495070128): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$239,000. This project is anticipated to be completed during the 2008 construction season.

W. Burleigh St. - N. 73rd St. to N. 76th St. (SM495070134): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$249,000. This project is anticipated to be completed during the 2008 construction season.

N. Carlton Pl. - W. Lisbon Ave. to W. Center St. (SM495070127): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$166,000. This project is anticipated to be completed during the 2008 construction season.

W. Roosevelt Dr. - N. 60th St. to N. Norwood Pl. (SM495070148): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$331,000. This project is anticipated to be completed during the 2008 construction season.

N. Sholes Ave. - W. Center St. to W. Hadley St. (SM495070158): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$66,000. This project is anticipated to be completed during the 2008 construction season.

N. 53rd St. - W. Center St. to W. Locust St. (SM495070154): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$349,000. This project is anticipated to be completed during the 2008 construction season.

N. 57th St. - A point 240 feet m/l south of W. Hadley St. to W. Burleigh St. (SM495070156): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated

cost for this project including the requested amount is \$578,000. This project is anticipated to be completed during the 2008 construction season.

N. 57th St. - W. Philip Pl. to W. Townsend St. (SM495070155): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$117,000. This project is anticipated to be completed during the 2008 construction season.

N. 58th St. - A point 150 feet m/l north of W. Roosevelt Dr. to W. Philip Pl. (SM495070157): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$81,000. This project is anticipated to be completed during the 2008 construction season.

N. 58th St. - W. Appleton Ave. to W. Burleigh St. (SM495070142): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$600,000. This project is anticipated to be completed during the 2008 construction season.

N. 61st St. - W. Appleton Ave. to W. Burleigh St. (SM495070143): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$145,000. This project is anticipated to be completed during the 2008 construction season.

N. 72nd St. - W. Chambers St. to W. Hadley St. (SM495070129): Relaying sanitary and storm sewers. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$394,000. This project is anticipated to be completed during the 2008 construction season.

#### 11th Aldermanic District

S. 41st St. - A point 125 feet m/l south of W. Oklahoma Ave. to W. Euclid Ave. (SM495070102): Relaying sanitary sewer and storm sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$155,000. This project is anticipated to be completed during the 2008 construction season.

#### 12th Aldermanic District

W. Maple St. - S. 12th St. to S. 13th St. (SM495070138): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$72,000. This project is anticipated to be completed during the 2008 construction season.

S. 12th St. - W. Greenfield Ave. to W. Lapham Blvd. (SM495070112): Relaying combined sewer and sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$237,000. This project is anticipated to be completed during the 2008 construction season.

S. 13th St. - The Kinnickinnic River to W. Harrison Ave. (SM495070132): Relaying combined sewer.

(Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$61,000. This project is anticipated to be completed during the 2008 construction season.

#### 12th and 13th Aldermanic Districts

S. 16th St. (Various Locations) - A point 235 feet m/l north of W. Burnham St. to W. Lincoln Ave. (SM495070137): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$538,000. This project is anticipated to be completed during the 2008 construction season.

#### 13th Aldermanic District

W. Saveland Ave. - S. Howell Ave. to S. 1st St. (SM495070136): Sanitary sewer lining. (Nonassessable Sewer Maintenance Relay Fund -- \$10,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2008 construction season.

S. 16th St. - W. Euclid Ave. to a point 225 feet m/l south of W. Euclid Ave. (SW172070107): Storm sewer relocation. (Developer Sewer Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$230,000. This project is anticipated to be completed during the 2008 construction season.

#### 14th Aldermanic District

S. Kinnickinnic Ave. - E. Potter St. to S. Logan Ave. (SM495070124): Relaying combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000). The total estimated cost for this project including the requested amount is \$179,000. This project is anticipated to be completed during the 2008 construction season.

S. 10th St. - W. Oklahoma Ave. to W. Ohio Ave. (SM495070119): Relaying sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$12,000): The total estimated cost for this project including the requested amount is \$392,000. This project is anticipated to be completed during the 2008 construction season.

#### Various Aldermanic Districts

Various Locations (ST212080001): Administration cost for alley paving engineering. (2008 Budgeted Funds -- \$25,000). The total estimated cost for this project including the requested amount is \$25,000. This project is anticipated to be completed during the 2008 construction season.

Various Locations (ST230080001): Administration cost for sidewalk paving engineering. (2008 Budgeted Funds -- \$80,000). The total estimated cost for this project including the requested amount is \$80,000. This project is anticipated to be completed during the 2008 construction season.

Various Locations (ST211080001): Administration cost for street paving engineering. (2008 Budgeted Funds -- \$800,000). The total estimated cost for this project including the requested amount is \$800,000. This project is anticipated to be completed during the 2008 construction

season.

Various Locations (ST210080001): Administration cost for new street paving engineering. (2008 Budgeted Funds -- \$50,000). The total estimated cost for this project including the requested amount is \$50,000. This project is anticipated to be completed during the 2008 construction season.

Various Locations (ST211080122): Asphalt resurfacing of various streets by contract. The total estimated cost for this project is \$300,000. This project is anticipated to be completed during the 2008 construction season.

Various Locations (ST211080123): Sealcoating of various streets by contract. The total estimated cost for this project is \$280,000. This project is anticipated to be completed during the 2008 construction season.

Various Locations (ST211080124): Crackfilling of various streets by contract. The total estimated cost for this project is \$200,000. This project is anticipated to be completed during the 2008 construction season.

Various Locations (SM495080001): Engineering studies throughout the City of Milwaukee. The total estimated cost for this project is \$600,000. This project is anticipated to be completed during the 2008 construction season.
