THE CHAIR

Substitute resolution determining it necessary to make various nonassessable public improvements at various locations. The City engineering cost for these projects is estimated to be \$1,603,000. The total estimated cost of these projects is \$16,106,000.

This resolution authorizes engineering studies on projects which by City Charter are nonassessable. After design plans and estimates of costs have been prepared, a resolution authorizing construction will be submitted to the Common Council. The City cost for engineering these projects is estimated to be \$1,603,000 with the total cost estimated to be \$16,106,000.

Resolved, By the Common Council of the City of Milwaukee, that it is necessary and in the public interest to do the following described improvements according to City specifications:
