## THE CHAIR

Resolution relative to acceptance and funding of a 2018 Beat Patrol Program Grant.

This resolution authorizes the Milwaukee Police Department to accept and fund a Beat Patrol Program Grant from the State of Wisconsin, Office of Justice Assistance, in the amount of \$168,952 with a grantor share of \$126,714 and a city share of \$42,238. The purpose of this project is to work with residents to identify and resolve crime and quality of life issues which impact upon the neighborhood. This is a continuing grant that currently funds a portion of two Police Officer positions. Whereas, The City of Milwaukee appears to be eligible for grant funds from the State of Wisconsin, Office of Justice Assistance for additional beat patrol officers to work with the residents to identify and resolve crime and quality of life issues which impact upon the neighborhood; and

Whereas, The operation of this grant from 01/01/2018 to 12/31/2018 would cost \$168,952 of which \$126,714 (75%) would be provided by the grantor and \$42,238 (25%) would be provided by the city; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that the Police Department shall accept this grant without further approval unless the terms of the grant change as indicated in Section 304-81, Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to:

1. Commit funds within the Project/Grant Parent of the 2018 Special Revenue Grant and Aid Projects fund, the following amount for the program titled: Beat Patrol Program Grant:

- 1. Expend from the amount budgeted for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
- 2. Transfer funds within the project budget as long as the amount expended for each specific purpose does not exceed the amount authorized by the budget by 10 percent; and, be it
