Substitute resolution approving levying of assessments and construction of assessable public improvement projects at various locations and appropriating funds for these purposes with the City cost of these projects approved by this resolution is estimated to be \$1,219,600 for a total estimated cost of \$1,297,600.

This resolution confirms the report of the Commissioner of Public Works, as modified by the Common Council Committee, on projects for which Public Hearings have been held. The resolution authorizes the levying of special assessments and directs the installation and construction of said public improvements. The City cost of these projects approved by this resolution is estimated to be \$1,219,600. The total estimated cost of these projects is \$1,297,600.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions, determining it necessary and in the public interest to construct and levy special assessments for the following improvements:

2nd Aldermanic District

N. 73rd St. -- W. Capitol Dr. to W. Congress St. (ST211180107) File Number 160587: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (8' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$48,000; Nonassessable Reconstruction Paving Fund -- \$450,000). The total estimated cost for this project including the requested amount is \$525,000. This project is anticipated to be completed during the 2018-19 construction season.

5th Aldermanic District

N. 85th St. - W. Locust St. to W. Burleigh St. (ST211150169) File Number 140430: Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (8' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$23,000; Nonassessable Reconstruction Paving Fund -- \$225,000). The total estimated cost for this project including the requested amount is \$270,000. This project is anticipated to be completed during the 2018-19 construction season.

W. Locust St. - N. 29th St. to W. Fond du Lac Ave. (ST211180118) File Number 161438: Concrete pavement reconstruction, replace all curb and gutter, sidewalk and driveway approaches, sodding (3' width of tree border area), and grading. (Assessable Reconstruction Paving Fund -- \$11,000; Nonassessable Reconstruction Paving Fund -- \$425,000). The total estimated cost for this project including the requested amount is \$465,000. This project is anticipated to be completed during the 2018-19 construction season.

W. Auer Ave. - N. 56th St. to N. 58th St. (ST211180217) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$5,000; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$7,000. This project is anticipated to be completed during the 2018 construction season.

12th Aldermanic District

W. Walker St. - S. 14th St. to S. 15th St. (ST211180209) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$3,400; Nonassessable Reconstruction Paving Fund -- \$4,900). The total estimated cost for this project including the requested amount is \$8,300. This project is anticipated to be completed during the 2018 construction season.

15th Aldermanic District

N. 24th St. -- W. Vliet St. to W. Cherry St. (ST211180199) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$4,000; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$6,000. This project is anticipated to be completed during the 2018 construction season.

N. 26th St. -- W. Lisbon Ave. to W. Vine St. (ST211180211) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$5,500; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$7,500. This project is anticipated to be completed during the 2018 construction season.

N. 50th St. -- W. Clarke St. to W. Center St. (ST211180204) Install traffic calming speed hump(s). (Assessable Reconstruction Paving Fund -- \$6,800; Nonassessable Reconstruction Paving Fund -- \$2,000). The total estimated cost for this project including the requested amount is \$8,800. This project is anticipated to be completed during the 2018 construction season.

Further Resolved, That the proper departments take such action as is required of them to assess the abutting or adjacent properties and collect such assessment in the manner directed by Section 115-42 of the Milwaukee Code of Ordinances; and, be it

Further Resolved, That the City Comptroller is authorized to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts; and, be it

Further Resolved, That the projects do not involve any parcels of agricultural land which are eligible for deferred special assessments under the provisions of Section 14.30 of the Milwaukee City Charter; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That project: N. 73rd St. (ST211180107); N. 85th St. (ST211150169); W. Locust St. (ST211180118); W. Auer Ave. (ST211180217); W. Walker St. (ST211180209); N. 24th St. (ST211180199); N. 26th St. (ST211180211); N. 50th St. (ST211180204) will be billed after January 1, 2020, but not before 12 months after the project contract has been completed; and, be it
