## The Chair

Substitute resolution relative to the acceptance and funding of the 2022 HIV Partner Services Grant from the State of Wisconsin Department of Health Services.

This resolution authorizes the Health Department to accept and fund the HIV Partner Services Grant from the Wisconsin Department of Health Services in the amount of \$222,000 with no city match. The purpose of the HIV Partner Services Grant is to reduce the incidence of HIV in Milwaukee through preventive health education services, HIV risk reduction education, referral services, partner services and focused disease intervention activities. This grant allows the Milwaukee Health Department to provide HIV testing services in the community as well as case finding and partner services for cases of HIV as defined in Wisconsin Statute.

Whereas, The City of Milwaukee appears to be eligible for grant funds from the Wisconsin Department of Health Services to reduce the incidence of AIDS/HIV in Milwaukee through preventive health education services, partner services and focused disease intervention activities; and

Whereas, The operation of this grant project from 01/01/2022 to 12/31/2022 would cost \$222,000 entirely provided by the grantor with no city match; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that application to the Wisconsin Department of Health Services is authorized and the Health Department shall accept this grant without further approval unless the terms of the grant change as indicated in Milwaukee Code of Ordinances Section 304-81; and, be it

Further Resolved, That the City Comptroller is authorized to commit funds within the Project/Grant Parent of the 2022 Special Revenue Grant and Aid Project fund, the following amount for the project titled 2022 HIV Partner Services:

- 1. Expend from the amount budgeted sums for specified purposes as indicated in the grant budget and incur costs consistent with the award date;
- 2. Expend from the 2022 grant budget for training and out-of town travel for staff;
- 3. Expend from the 2022 grant budget for equipment as specified in the grant budget;
- 4. Expend from the 2022 grant budget for strategic planning and contractual services; and be it
