An ordinance relating to the amendment of the Official Map of the City of Milwaukee.

1. Alley in the block bounded by West North Avenue, North Oakland Avenue, East Windsor Place and North Bartlett Avenue. The vacation of the northerly 250 feet more or less of the 14-foot wide alley right-of-way.
