THE CHAIR

Resolution approving construction of nonassessable public improvements at various locations and appropriating funds for these purposes with the City construction cost estimated to be \$4,629,534 for a total estimated cost of these projects being \$7,927,379.

This resolution directs the installation and construction of certain public improvements which have been determined to be nonassessable by the Commissioner of Public Works. The City cost of the projects approved by this resolution is estimated to be \$4,629,534. The total estimated cost of these projects is \$7,927,379.

Whereas, The Common Council of the City of Milwaukee adopted preliminary resolutions determining it necessary and in the public interest to construct nonassessable improvements; and

Whereas, Plans, specifications and cost estimates have been prepared for the following described improvements:

3rd Aldermanic District

1311 E. Chambers St. (WT450075600): Riverside Pumps 6A and 6B Contract (C641090047). (Nonassessable Water Fund - \$200,000, Additional Funds). The total estimated cost for this project including the requested amount is \$833,845. This project is anticipated to be completed during the 2011 construction season.

N. Maryland Ave. - N. Prospect Ave. to a point north of N. Prospect Ave. (ST211100161) File Number 100494: Concrete curb and gutter. (Nonassessable Reconstruction Paving Fund -- \$35,000). The total estimated cost for this project including the requested amount is \$36,000. This project is anticipated to be completed during the 2010 construction season.

E. North Ave. Sink Hole (SM495100160) File Number 100494: (Nonassessable Sewer Maintenance Relay Fund -- \$999,000). The total estimated cost for this project including the requested amount is \$1,000,000. This project is anticipated to be completed during the 2010 construction season.

4th Aldermanic District

E. Buffalo St. - N. Water St. to N. Milwaukee St. (WT410081012): File Number 091433: Relay water main. (Nonassessable Water Fund -- \$100,000, Additional Funds). The total estimated cost for this project including the requested amount is \$550,000. This project is anticipated to be completed during the 2010 construction season.

E. Kilbourn Ave. at N. Prospect Ave. (ST211100160) File Number 100494: Median revision.

(Nonassessable Reconstruction Paving Fund -- \$13,000). The total estimated cost for this project including the requested amount is \$14,000. This project is anticipated to be completed during the 2010 construction season.

10th Aldermanic District

W. Blue Mound Rd. - N. 79th St. to N. Glenview Ave. (SM495090070) File Number 100217: Sanitary relay and new sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$2,500,000). The total estimated cost for this project including the requested amount is \$4,700,000. This project is anticipated to be completed during the 2010 construction season.

13th Aldermanic District

900 feet m/l east of S. 20th St. - W. Mallory Ave. to W. Grange Ave. (SM495080018) File Number 080237: Relay sanitary sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$83,534). The total estimated cost for this project including the requested amount is \$95,534. This project is anticipated to be completed during the 2010 construction season.

15th Aldermanic District

N. 26th St. at W. Vine St. (SM495100154) File Number 100494: Relay combined sewer. (Nonassessable Sewer Maintenance Relay Fund -- \$699,000). The total estimated cost for this project including the requested amount is \$700,000. This project is anticipated to be completed during the 2010 construction season.

City of Wauwatosa

300 feet north of W. Concordia Ave. - N. Argonne Dr. to N. Menomonee River Pkwy. (WT410031000) File Number 081267: Rescind the authority to water main extension. (Nonassessable Water Fund - \$225,000). The water main will not be extended at this time because of a new plan development. The total estimated cost for this project is \$225,000. The project was anticipated to be completed during the 2010 construction season. Rescind nonassessable. The final resolution No. 081267 was adopted on February 10, 2009; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee that the Commissioner of Public Works is authorized and directed to proceed with said work; and, be it

Further Resolved, That the Department of Public Works is authorized to use the funding as specified in the above description of work; and, be it

Further Resolved, That the City Comptroller is authorized and directed to transfer such funds which are available for this purpose to the appropriate capital Project/Grant accounts.
